### **ENGINEER'S REPORT**

Mr. Bacolo discussed the Arscenic treatment project update, continuing with design, working with AdEdge. Crew has submitted the application for temporary treatment approval for the water pods to the NJDEP which will allow Ramsey to pre-purchase the pods. Crew is continuing with the design of the pods along with structional design. Also, continuing with application to submit to NWBCUA for discharge of backwash. Design docs and bids for pod installation will be complete in the second week of June and anticpating delivery of contracts in July. Delivery of pods is expected for December 2019. Mr. O'Rourke asked how long for approval from NJDEP. Mr. Bacolo responded 30-40 days. Mr. Vozeh asked about timing. Mr. Bacolo responded that the start of installation is anticpaticed late November/early December.

Spring Street well arscenic treatment project first phase of update. CFM has sent back contracts and bonds. They have been reviewed by Mr. Corriston and are ready to sign. CFM has begun submitting shop drwaings.

Mr. Bacolo has one item for executive session.

## **OPERATIONS REPORT**

Mr. Skorupa presented his monthly written report to the Board.

The water department performed their daily duties, along with inspecting, marking, cleaning and repairing water valves and manholes.

Water main breaks were repaired on Navajo Dr. and Fuhrman Ave.

Hydrant flushing has been completed.

### **OPERATIONS MANAGEMENT REPORT**

Mr. DeBlock reported on his site visits to two Ad Edge locations in Arizona. He spoke with the staff at each location. Equipment was in good condition considering the harsh desert conditions.

Mr. DeBlock and Mr. Skorupa are meeting to discuss the pod design.

Mr. Kilman asked who will be servicing the pods in our pump houses. Mr. Bacolo responded that the media lasts for several years, AdEdge and a contractor would service them when the time comes. Mr. O'Rourke asked if our generators are strong enough to run them. Mr. Bacolo responded that he believes they are, however this will need to be evaluated further and proper testing will need to be done.

**ATTORNEY'S REPORT** nothing to report. Absent.

MAYOR'S REPORT Mayor Dillon was absent. Mr. Vozeh relayed her report on Ramsey Clean-up day, it was success with over 90 people participating. It was attended by the Mayor, Councilwoman Jachzel and Councilman Weber. The Environmental commission is sponsoring a collection of plastic bags, including dry cleaning bags for a special program which will award a Trex composite bench to our community. The boxes can be found at the Borough Hall, Recycling center and the library.

<u>COUNCIL LIAISON'S REPORT</u> Mr. Kilman discussed 83 Grant Street and questions surrounding this property and the LSRP. He asked Mr. Bacolo how this is being addressed. Mr. Skorupa responded that excavation work is being performed there. Mr. Bacolo responded that Crew will look into the status with the NJDEP for the work being performed at this address.

<u>ADMINISTRATOR'S REPORT</u> – Mr. Vozeh discussed the new water & sewer service connection for the pool house which is under construction. This connection is not part of the Board of Public Works budget, it falls under the pool budget. John Garcia was the lowest bid. Mr. Vozeh asked Crew to put together the drawings for the specifications needed to be submitted the contractor. The submission of drawings and bid will be performed by the Borough and/or the pool commission.

Motion by Mr. Martin to recommend that the Pool House water and sewer connection scope of work meets Board's standard and John Garcia is a reliable contractor, seconded by Mr. Emmer. Carried.
